RESEARCH PROJECTS:

Meeting Masters Research Project

Here I explore the patterns through which meeting masters achieve - continually - high quality decisions in the groups they lead under a wide range of conditions. I interview meeting masters and cull their best practices. I also observe "bad" meetings. The effort here is ongoing, and I continue to find and add new examples of meetings masters (and meeting idiots) to the data base. The idea of decisions is coming to play a larger role in this research. Several publications have come from this research project. It was funded, in part, by the 3M project in meeting management.

Nonprofit Executive Pay Project

Here I explore the rates and rationales of nonprofit executive pay. I am especially interested in the gender differential in executive pay in nonprofits, which is shameful. Not only are women paid less, but they lack position in the "executive pipeline" which would position them to good positions further on.

The Family Success (ion) and Failure Project

This project reviews a series of business in which children have destroyed business their parents (and grandparents in some instances) have developed. This project involves both organizational and family dynamics. The question of how these problems happen and what are the issues involved are fascinating ones. This project is an ongoing one, in which I am collecting data at this point.

Long Distance Mobility Project

This project explores the stories, and hopefully patterns, of individuals who have "escaped" from a poverty childhood ("lowest social class") and succeeded at the highest levels in conventional American terms (the highest social class.") I will also be looking at those who have "remained" in the class of origin. This project is an ongoing one; I am in the process of securing data at this time.

Leadership Calamity /Corporate Catastrophe Project

This research looks at the patterns of leaders who experience "calamity." Calamity occurs when an executive or executive set lose his/their position(s) and bring down their family, their firm, their industry, and even part of the country, with them (Enron, Anderson, United Way of America, Global Crossing, etc. etc.) I am interested in selecting among several competing hypotheses to explain this kind of self/other destructive behavior. I have about 200 "cases" – individuals who have been written up in major newspapers, as "data" for an initial exploration. At the same time I am looking at the organization structures in which thee events occur. I see the problem as an interactive one, with individual characteristics and competencies on the one side, organizational conditions on the other side, and social context as affecting each. I am in the process of preparing an article and a book on this subject matter.

Social Welfare Forum Project

For about 100 years, 1888 to 1978, the social work profession got together at a big yearly conference and published the significant papers from that event. Initially called the Conference on Charities and Correction, and later called the National Social Welfare Assembly, their reports provide an invaluable historical resource about he history of social welfare. This year I began a new project to develop a book that records in one place all the papers, and provides decade by decade analysis of the evolution of the field, intellectually speaking. This project will be my sabbatical project. It involves not only listing all the papers, of course, but reviewing a sample or the articles to provide an updated history. (There was one history written in 1912 that did this, and another in 1948; however in each of those cases there was no record of what the author's actually did or how they did it.)

ILLUSTRATIVE COURSES

School of Social Work: Nonprofit Management

Social Work 665 • Executive Leadership

This course examines the attributes, skills, behaviors, problems and issues associated with higher administrative roles in human service organizations, both public and private. Various styles of leadership are also analyzed with reference to the stages of organizational development. Among the executive functions given particular attention are: defining the mission and goals of the organization, mobilizing resources, selecting service technologies and staff, developing the appropriate internal-external structures, and adapting the organization to changing environments. Gender and race are examined as critical intervening variables affecting both individual and organizational behavior. Integration of professional and personal roles in also examined.

Social Work 664 • Human Resources Management

In this course, human resources is defined as planned processes that are designed to improve the ability of staff members to do their job so that the human service organization in which they work can achieve its goals, and the staff are satisfied with their work experience. Based on this broad definition, a number of activities are included, such as work organization and job analysis, recruitment, affirmative action and hiring processes, performance appraisal, and compensation and benefit arrangements. Basic principles and techniques for the management of these activities will be reviewed in lecture and/or readings.

In addition, a number of staff development activities can be identified. These include individual and group supervision and consultation, orientation, problem-solving staff meetings, in-service training, educational leave, out-service education (e.g., conferences, workshops, evening courses, etc.), operation of an agency library, staff's participation in the development of an accountability system, field trips to cooperating organizations, serving as a training site for students, participation in research on performance evaluation, and informal social functions for staff.

Social Work 845 • American Values and Social Policy

This doctoral course explores the American value system, its content and structure, and explores the impact of both content and structure on social policy, dysfunction, formation, decision, and implementation.

Other courses have included community regulation, social policy history and methods, and the management of private practice.

Michigan Business School: MBA Program

Organizational Behavior 562 • Rewards Systems: Theory and Administration

This course reformulates the older "compensation and benefits" course into a broader, more integrated human resources perspective. It asks "Rewards for what?" and "Rewards for whom?" and "What are rewards, anyway?" A total compensation model is presented: TC = BP _+AP + IP + PP + WP + OG + OA + PI. Where TC = Total Compensation; BP = Base Pay; AP = Augmented Pay (from suture to phantom stock); PP = Perkspay; WP = Works Pay; OG = Opportunity for Growth; OA = Opportunity for Advancement; and PI = Psychic Income. It is called cafeteria compensation and argued to be, and be managed as, a system.

Other courses have included organizational design, entrepreneurship, and basic management.
