## Please read the General Information and Notes before viewing the ballot archive.

## General Information

The Leon County Supervisor of Elections Office is making this archive of scanned images available so the public can view the Overvoted November 7, 2000 Presidential Race Ballots submitted to the Leon County Supervisor of Elections Office for vote tabulation.

These 56 ballots were submitted to our office by voters during the November 7, 2000 General Election, either as Absentee Ballots or as Unscanned Ballots from the precincts. The images contained herein are scans of the original ballots submitted by the voters, not scans of the re-created ballots.

Because each of these ballots has marks that were interpreted by the voting machines as more than one choice in the Presidential Race, and because the voting machines were programmed to reject any ballots having an overvote situation, none of these ballots were counted by a voting machine. Instead, re-creations of the ballots were marked by the Canvassing Board in a manner consistent with the clearly identifiable voter intent, as outlined below. These re-creations were then counted by machine.

The first 36 ballots (images 1 through 36) in this series had clearly identifiable voter intent in the Presidential Race. The Canvassing Board re-created these ballots with a vote cast for a Presidential Candidate as intended by the voter. The remaining 20 ballots (images 37 through 56) did not have clearly identifiable voter intent. Therefore, no votes for a Presidential Candidate were re-created for these 20 ballots.

## Notes

- The Adobe Acrobat Reader is required to view the archive. If you do not already have the Adobe Acrobat Reader, it is free and nearly indispensable for viewing documents on the web.
- Each scanned ballot image is bookmarked by image number (x of 56 ). The archive has 57 pages. The first page contains a copy of this explanation. Pages 2 through 57 contain the ballot images.
- In order to provide this archive in a manageable size, the ballots were scanned at a resolution of 300dpi and a Black/White format. The quality of the scanned images has been checked and verified.
- The archive is QUITE LARGE (approximately 7.11MB). It will take quite a while to download. The archive is available on CD. The archive CD will cost $\$ 3.00$ if picked up from the office, and $\$ 3.50$ if mailed. Paper copies of the archive can be purchased at our office at the standard rate of $\$ 0.15$ per page.
